1. I would like to sign up for Animalia Learning Center.
2. FEES: Details for different packages and days per week to follow. This can also be downloaded from our website on p1. SUMMARY: The usual rate is R300/day Ad Hoc and try out when the child attends without parents. Packages vary from R247.50/day for full time (Mon -Thurs, R3960 monthly), R297 one day/week (R1188 monthly) and everything in between. Siblings discount is available and fees are adjustable according to parents' financial means.
3. Try-out days: 2 - 3 days.
 - R300 per day = R900 for the trial period.
 - If your child is happy to stay following the trial period, these days are included in the monthly invoice as per the package selected.

7. I understand that this means my child has access to the premises at 14A Clement Stott Road, Assagay, and that I indemnify Animalia Learning Center, its workers, facilitators, caregivers and all other staff against any accidents that may arise from the use of the resources and grounds of the Center. I further agree to the condition that, while every precaution will be taken for the safety and welfare of my child and for the care of his or her possessions, I will hold blameless and indemnify all persons, Animalia Learning Center and all other organisations associated with the activity, should any prejudice, loss, damage, illness or injury occur to my child during the above activity. This includes an indemnity against recovery of costs resulting from damage, loss and/or medical conditions or hospitalisation, unless such loss is caused by the negligence, wilfulness or deliberate act of the Center or one or more of its employees. I furthermore appoint the Center staff supervising the activity, to act in loco parentis in respect of my child should the need therefore arise.
8. Fees are paid for in advance of every month. A written period of 1 calendar month is required on termination of my child's attendance. This is invoiced for in advance as applies to all months.

11. Animalia Learning Center operating hours: Monday – Thursday 8.30am to 1pm.
12. I understand that the resources on offer may include (but are not limited to): access to high speed fibre for online educational and research purposes, Educational toys like Lego and numeracy equipment; sports equipment; outdoor playground equipment; books and other reading materials; kitchen equipment, DIY hand tools and power tools, garden tools, science equipment.
13. All stationery, art & craft and related materials, as well as workbooks, teas & coffees and sugars etc are to be supplied by each child for their personal use and as required by facilitators for specific activities should the child choose to do the activity.
14. The daily program includes indoor and outdoor independent learning, facilitated learning, games, learning activities (online and offline), developmental programs that cover the social sciences, numeracy, language and life skills development.
15. I understand that classes offered by external people at Animalia Learning Center premises are billed privately. Animalia Learning Center acts herein as an introductory intermediary only.
16. I understand that courses, clubs and classes on offer will change from time to time and that I will be notified of such changes timeously.
17. I understand that should my child deliberately or maliciously break or damage any materials or property that I will be held liable for the repair or replacement of such.
18. I understand that in the event of behavioural concerns arising I may be requested to be present while my child is at the center.
19. I understand that the rules set up by the children within their democratic meetings will not be overturned by adults as long as they do not over rule acceptable or dangerous behaviour.
20. I give permission for my child to go on Adult-led exploratory walks/bicycle rides around the secure neighbourhood to the parks and secure river and swimming pool as and when offered.

23. The center is not responsible for any child's education as such as it remains the parent's responsibility to monitor their progress. The center staff act as facilitators only. Should your child require extra tutoring for example to bridge gaps in certain learning areas, this can be arranged at an additional cost at the center. Enquire for more details.
24. The center provides free and unlimited access to internet for digital learning purposes. However it is for the child to provide and bring their own digital devices, such as a laptop.
25. Please remember that you need to provide food and snacks for your child, change of clothes, gumboots, as well as one box of tissues per child per term. Water will always be freely available.
26. Animalia reserves the right to register or deregister learners at their discretion. Selection is based on an amicable cooperative group dynamic amongst the learners.
27. Payment Details:

Payment needs to be made monthly in advance for attendance to Animalia Learning Centre.

Invoices are sent out on the 25th of each month in advance of the next month. Payment is due by latest the 28th of the same month (3 days after invoice). Invoicing is via email only unless otherwise required by parents.

R20 per day penalty fee for late payments will be added to the parent's account if due date is not met.

All Classes and Courses that are additionally charged for need to be paid for at the start of each course/class term or as per instructions pertaining to that activity. Any other additional costs such as extra lessons and activities will be invoiced for on the last attendance day of each month.

I acknowledge that any bank fees for returned amounts will be for my own account as will legal fees for the collection of outstanding fees.
